#### **1.1 Government relations & policy advocacy**

- Ongoing dialogues and consultations with the regional branches at Global Affairs Canada, in particular the Sub-Saharan Africa Branch and its Pan-Africa Bureau; the Americas Branch and its North America, Central America, Latin America & Caribbean Bureaux; and the Asia-Pacific Branch and its Southeast Asia bureau. 
 November 2018 | APWG held the documentary screening and panel discussion "Five Years After the Storm: The Humanitarian-Development Nexus in Practice" on the humanitarian development nexus in practice marking the 5th anniversary of Super Typhoon Haiyan and recovery effort in the **Philippines**, in partnership with Development & Peace, and the CICC-CASID Next Generation Program.

The documentary follows a devastated community as it is empowered to take charge of its own future and build a new community and new lives, as the Pope Francis Village. Following the documentary, there was an interesting panel discussion with experts from different institutions.

CCIC's Nicolas Moyer moderated the panel led by Jess Agustin of Development and







Peace, Furqan Asif of the University of Ottawa, Carine Bigira, of the Humanitarian Coalition, and John Summerbell of Global Affairs Canada, who reflected on how to improve humanitarian responses and community preparedness to climate change and natural disasters. **Read more here**;

#### 2.2 Government relations & policy advocacy

 Ongoing policy recommendations and advocacy regarding the *deterioration of human rights in the Philippines* and the rise of extra-judicial killings and militarisation of the country;



 October 2018 | APWG denounced the Sagay massacre of 9 farm workers, including 3 women and 2 minors;



 January 2019 | The APWG-Philippines subgroup held a meeting with GAC officials regarding the human rights situation in the **Philippines**, following a fact-finding delegation of Canadian civil society to the country;




